

An announcement of Khuruprachasan School Intention for Good Governance of Khuruprachasan School

Khuruprachasan School has given priority to administration with morality and transparency in accordance in accordance with the Royal Decree on Criteria and Procedures for Good Country Administration, B.E. 2546 (2003) and the National Economic and Social Development Plan No. 12 (2017 – 2021) as well as the policy (Prime Minister Prayut Chan-o Cha) prescribed on September 12, 2014, related to the government administration with good governance to build the government's trust and moral system and prevent corruption and misconduct in accordance with national strategies. In terms of preventing and suppress corruption phase 3 (2017-2021) and the prevention and suppression of corruption and misconduct in the government sector according to the Civil Service Code of Ethics 2009, a manual on prevention of conflicts of interest (conflict of interest between personal benefits and common interest) of government officials in Khuruprachasan School and in accordance with the Integrity and Transparency Assessment (ITA) of National Anti-Corruption Commission (NACC) and Office of Public Anti- Corruption Commission (PACC).

In this regard, I, Mr. Phadet Supantana, would like to express my intention to the public as the administrator of Khuruprachasan School. Ready to promote all government officials and personnel under the jurisdiction must perform their duties with integrity and transparency, resulting in the highest efficiency and effectiveness for the government ready to protect the interests of the state and provide fairness to the people equally and will perform administrative duties in the prevention and suppression of corruption in the government agency with awareness of the responsibility, intend to perform our duties with full intelligence and ability with honesty and prudence, knowing what is right, what is wrong, what should be done and what should be avoided, to be free from damage and achieve maximum benefits by adhering to the principles of good governance in management and will against all corruption. On behalf of the administrators at all levels of Khuruprachasan School, I hereby declare the intention that I will operate work with honesty, transparency, good governance, reliability and accountability in order to create confidence in the society that Khuruprachasan School is determined to fight against all forms of corruption. We will adhere to making Khuruprachasan School a sustainable clean government organization. We will proceed as follows.

- 1. Strictly perform all procedures in accordance with the laws, rules, and regulations, as well as encouraging personnel to work in accordance with the laws, rules and regulations as specified.
- 2. Cultivate and raise awareness about the values of anti-corruption, know how to distinguish between personal benefits and common interest to instill a sense of morality and prevent corruption in departments.
 - 3. Do not accept corruption behavior and do not tolerate all of corruption.
- 4. Instill awareness of students in Khuruprachasan School so that they can realize bad consequences and go against corruption.
 - 5. Guidelines for operations and cooperative activities
- 5.1 Coordinate and cooperate with various departments for the implementation of national strategy driving on the Prevention and Suppression of Corruption Phase 3 (2017-2020).
- 5.2 Personnel cooperate to join a network of prevention and suppression all corruptions all department level and other agencies both public and private sectors.
- 5.3 Conduct research studies, gather knowledge on prevention and suppression of corruption.
- 5.4 Provide knowledge about national strategies preventing and suppress corruption phase 3 (2017-2021), especially the guidelines for promoting morality and ethics to personnel to create knowledge, understanding and participation in publicity campaign against corruption.
 - 5.5 Public relations to support on prevention and suppression of corruption.
- 5.6 Take other actions in all forms of the prevention and suppression of corruption with full capacity. I hereby confirm that Khuruprachasan School will adhere to being a government agency with transparent and verifiable to be consistent the vision of the Office of the Basic Education Commission that "Basic education in Thailand is of international quality and standards on the basis of Thainess."
